IMPORTANT: If you do not meet the eligibility requirements for the ME Licence (for example you don't yet have 3 years work experience) you may want to wait and only apply to write the ME exam when you meet all of eligibility requirements.

While you can challenge the exam before you gain 3 years experience, you cannot obtain a ME licence without this experience and the exam results are only valid for 12 months.

The following **must** be provided together with this completed application:

- Date and location of the exam requested (see exam schedule at www.esasafe.com/contractors/me-exam).
- Personal contact information, including email address. If ordering books please ensure your full mailing address is included.
- Declaration signed on page 1.
- Copy of a valid government photo identification (such as passport, drivers licence, etc.)
- If applicable* - Copy of ME licence or similar certificate if applying from another Province

- It is understood that all exam candidates with comply with ESA's Master Electrician Rules of Conduct available at www.esasafe.com/contractors/me-exam/
- Processing Times:
Exam application - ESA must receive your completed exam application a minimum of ten (10) working days prior to the examination date. Registration into an exam session is on a first come first serve basis. Visit our website for scheduled sessions.
- Transferring exam dates: Changing exam dates is highly discouraged – if affects other exam applicants and is disruptive to the process. **All exam transfers will result in a transfer fee.** Applicants MUST write within one (1) year of exam date listed on original application. Retake Policy:

- Applicants that fail the exam two times are asked to take any type of Master Electrician preparatory training course or Code training course; either from ESA, or an accredited college/training facility/company, before attempting the exam a third time.
- You will be allowed to schedule another examination immediately after your previous examination as long as space is available. For each examination attempt, you must pay submit an application and fee
- Regardless of the time that has passed, after two failed attempts, the requirement to take training applies.
