#### 1.0 Notice and Quorum

- A snow storm kept several UAC members and ESA staff from attending this meeting
- In the meeting, it was determined that quorum existed so voting proceeded on several items. However analysis post meeting determined, there was not quorum so those items will require re-voting at the next meeting

#### **UPDATES**

- 2.0 Ontario Electrical Safety Code Section 75 Status Ted Olechna
  - Balloting had just been completed and the updates/changes to Section 75 will be incorporated into the next code

#### 3.0 2-005 Meter Transfer Devices - Ted Olechna

 The OESC currently has an exemption that allows a Utility to disconnect and reconnect a consumer service for a Licensed Electrical Contractor to install a meter transfer device without the need for a connection authorization

**ACTION:** ESA will send an e-mail to the Utilities for feedback on the proposed changes to 2-005 – Ted Olechna (Action Item 2014-09)

- **4.0** Smart Meter Update UL Standard Development for Canada Jason Hrycyshyn (see presentation)
  - This is the 1<sup>st</sup> standard for safety
  - This is a UL standard for Canada only
  - UL is targeting the summer of 2015 for completion of this standard

# **5.0** OEB Scorecard for LDC's – Safety Metric Update – Normand Breton (see presentation)

- To monitor the effort and impact LDCs are having on improving public electrical safety for the Distribution Network
- Timelines and working group progress was discussed

## **6.0** Approval of the Minutes

- A vote was taken to approve the minutes from February 27, 2014, May 22, 2014 and October 2, 2014
- It was discovered after the meeting that we did not have quorum and will need to revote to approve the minutes at the next UAC meeting

### 7.0 Update UAC Terms of Reference – Farrah Bourre

- The Terms of Reference were updated to add in a term for the Vice Chair position
- The term for the Vice Chair is 2 years with the option to renew for another 2 year term
- A vote was taken to approve the updated UAC Terms Of Reference, however, it was determined after them meeting that we did not have quorum.

### 8.0 Vote for UAC Vice Chair

- A vote was taken to approve Greg Sheil as Vice-Chair
- It was determined after them meeting that we did not have quorum
- **9.0** Ontario Electrical Safety Code Implementation Dates Ted Olechna (see presentation)
  - ESA submits its changes to the government as a proposal and the government has to approve
- **10.0** Temporary Overvoltage Working Group Jason Hrycyshyn (see presentation)
  - 1st meeting is scheduled for December 12, 2014
  - Scope of the working group was reviewed
  - The question was asked about an overvoltage earlier in 2014 and if life safety devices had been replaced as a result of this over voltage event
- **11.0** Asset Management Daria Babaie Ontario Energy Board (see presentation)
  - The Asset Management section of the LDC Scorecard was discussed
- **12.0** ESA's Holiday Electrical Safety Campaign Kathryn Chopp (see presentation)
  - ESA's Holiday Electrical Safety Campaign was discussed
  - Focus on product safety, installation and operation, and storage
  - The Holiday Safety Video was shown (available on YouTube)
  - The Consumer (non-occupational) campaign will begin in April 2015
  - ESA's Occupational campaign will begin once construction season starts in the spring
  - Utilities present supported the idea of working with educational materials produced by ESA
  - The OEB thinks integrating ESA safety material into the LDC safety metric is a good idea
  - ESA would like to see more Utility involvement at the ground level when creating future awareness materials and campaigns
- **13.0** Updated Auditor Qualifications (Action Item 2014-07) Jason Hrycyshyn (see presentation)
  - Auditor qualification requirements were reviewed
  - Questions raised at the October UAC meeting were reviewed and ESA is satisfied that the changes to the Audit Guideline are positive
  - ESA will monitor this and make changes as necessary
- **14.0** Introduce clearances (CSA clearances) for distribution, street lighting and communications Patrick Falzon (see presentation)
  - Street lighting working group has been reconvened

- The scope of the working group was reviewed and it was explained that it is for the public only
- It was explained that rule 30-1030 only applies when street lighting is attached to customer owned poles
- When street lighting is installed on Utility owned poles then CSA requirements are the minimum standard that a Utility has to meet
- ESA was asked if rule 30-1030 is captured in a bulletin to highlight when it applies and when it doesn't
- Because most utilities have their own standards a communications company would need to communicate with each utility to come to an agreement as to how issues with clearances will be handled

**ACTION:** ESA to create a bulletin that explains when rule 30-1030 applies and when it does not – Patrick Falzon (Action Item 2014-10)

- **15.0** Serious Electrical Incidents Patrick Falzon (see presentation)
  - 2 incidents were discussed
- **16.0** Compliance Incident Dead-Leg Undue Hazard Jason Hrycyshyn (see presentation)
  - A Utilities use of a Dead-Leg adapter was discussed
  - The Utility was found in non-compliance with Regulation 22/04 in this situation
- **17.0** History Lesson Regulation 22/04 (DDIs, Audits, SEIR, PSC) Jason Hrycyshyn (see presentation)
  - Some of the changes and focuses within Utility Regulations over the last several years were discussed
  - Due Diligence Inspections being adjusted based on risk
  - Number of Utilities that had no findings on their audit
  - Auditor questions and answers were reviewed
- **18.0** Auditor Debrief Jason Hrycyshyn (see presentation)
  - The information discussed at the Auditor Debrief meeting was shared with the UAC
- **19.0** New Business
  - There was no new business
